TERMS OF USE AGREEMENT

1. ACCEPTANCE OF TERMS.

Your use of the JetLimo, Inc. website (the "Site"), services and/or products (collectively, the "Services") is subject to this Terms of Use Agreement (the "TOU Agreement").

BY ACCESSING, BROWSING AND/OR USING THE SERVICES (referred to as "Use" or "Using" the Services), YOU ARE DEEMED TO ACCEPT THIS TOU AGREEMENT AND YOU AGREE TO BE BOUND BY THIS TOU AGREEMENT WITH RESPECT TO USING THE SERVICES. IF YOU DO NOT WISH TO BE BOUND BY THIS TOU AGREEMENT, DO NOT USE THE SERVICES.

2. REVISIONS TO THE TOU AGREEMENT.

JetLimo, Inc. ("JetLimo") may revise this TOU Agreement in its sole discretion. Each time changes are made to this TOU Agreement, a revised TOU Agreement will be posted on the JetLimo home page. If you continue to Use the Services following the posting of a revised TOU Agreement, it will constitute your acceptance of any such changes and of the revised TOU Agreement. The Services and all photographs, information, data, text, software, music, sound, graphics, video, messages, tags or other materials (the "Content") are intended for your personal or internal business use. Unless otherwise noted, all Content provided by the Services is the property of JetLimo or our licensors, and protected by United States and international copyright laws. All software used on and provided by the Services is the property of JetLimo or our licensors and protected by United States and international copyright laws. Subject to the terms of this TOU Agreement, JetLimo hereby grants you a limited, non-exclusive, nonsublicensable, non-assignable license to Use Services for your personal or internal business use only. You may not attempt to discover any source code, modify, publish, adapt, transmit, participate in the transfer or sale, exhibit, distribute, display, reverse engineer, decompile, disassemble, perform, reproduce, create derivative works from, or in any way exploit any of the Services, in whole or in part. 5. AUTOMATED QUERIES ARE NOT ALLOWED.

Automated queries may never be sent by you to our Services unless JetLimo has provided you with express written permission. "Sending automated queries" includes, among other things:

- (a) using any software which sends queries to our Site to determine how a Website or Webpage "ranks" for various queries;
- (b) "meta-searching"; and
- (c) performing "offline" searches on the Site.

6. SERVICES MATERIALS.

A. You agree to:

- only Use (or attempt to Use) the Services through interfaces provided by JetLimo;

You agree to not use the Services to:

- engage in activity that is in violation of this TOU Agreement or is unlawful, harmful, threatening, abusive, harassing, tortuous, defamatory, vulgar, obscene, libelous, invasive of another's privacy, hateful, or racially, ethnically or otherwise objectionable;
- harm or threaten to harm users in any manner;
- harm or threaten to harm minors in any manner;
- stalk or harass any person or entity;
- impersonate any person or entity or otherwise misrepresent your affiliation with a person or entity;
- forge headers or otherwise manipulate identifiers in order to disguise the origin of any Content transmitted through the Services;
- infringe any patent, trademark, trade secret, copyright or other proprietary rights of any party;
- engage in activity that may interrupt, destroy or limit the functionality of the Services or of any computer software or hardware or telecommunications equipment;
- disrupt the normal flow of dialogue or act in a manner that negatively affects other users' ability to engage in real time exchanges;
- interfere with or disrupt the Services or servers or networks connected to the Services, or disobey any requirements, procedures, policies or regulations of networks connected to the Service;

B. You acknowledge, consent and agree that JetLimo may access, preserve and disclose your account information (if such information exists) if required to do so by law or in a good faith belief that such access preservation or disclosure is reasonably necessary to: (a) comply with legal process; (b) enforce this TOU Agreement; (c) respond to claims that any of your acts violate the rights of third parties; (d) respond to your requests for customer service; or (e) protect the rights, property or personal safety of JetLimo, its users and the public.

9. INTERSTATE DATA TRANSMISSIONS

You understand that the technical processing and transmission of the Services, including your Content, may involve (a) transmissions over various networks; and (b) changes to conform and adapt to technical requirements of connecting networks or devices. You understand that the Services and software embodied within the Services may include security components that permit digital materials to be protected, and that use of these materials is subject to usage rules set by JetLimo and/or content providers who provide content to the Services. You may not attempt to override or circumvent any of the usage rules embedded into the Services. You agree to indemnify and hold JetLimo and its affiliates, subsidiaries, officers, agents, employees, partners and licensors harmless from any claim or demand, including reasonable attorneys' fees, made by any third party due to or arising out of your Use or misuse of the Services, your connection to the Services, your violation of the TOU Agreement, or your violation of any rights of another.

12. NO RESALE OF SERVICES

You agree not to reproduce, duplicate, copy, sell, trade, resell or exploit for any commercial purposes, any portion of the Services.

13. MODIFICATIONS TO SERVICE

JetLimo may modify or discontinue, temporarily or permanently, the Services (or any part thereof) with or without notice. You agree that JetLimo shall not be liable to you or to any third party for any modification, suspension or discontinuance of the Services.

14. TERMINATION

You agree that JetLimo may, under certain circumstances and without prior notice, immediately terminate your access to the Services. Further, you agree that all terminations for cause shall be made in JetLimo's sole discretion and that JetLimo shall not be liable to you or any third party for any termination or access to the Services.

JETLIMO AND ITS AFFILIATES, SUBSIDIARIES, OFFICERS, EMPLOYEES, AGENTS, PARTNERS AND LICENSORS EXPRESSLY DISCLAIM ALL WARRANTIES OF ANY KIND, WHETHER EXPRESS OR IMPLIED, INCLUDING, BUT NOT LIMITED TO THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND NON-INFRINGEMENT.

21. TRADEMARKS

Without JetLimo's prior permission, you agree not to display or use in any manner the JetLimo marks.

22. GENERAL INFORMATION

Entire Agreement. this TOU Agreement constitutes the entire agreement between you and JetLimo and governs your use of the Services, superseding any prior agreements between you and JetLimo with respect to the Services. You also may be subject to additional terms and conditions that may apply when you use or purchase certain other JetLimo services, affiliate services, third-party content or third-party software.

Choice of Law and Forum. This TOU Agreement and the relationship between you and JetLimo shall be governed by, construed and enforced in accordance with the laws of the State of California, excluding its conflict of law provisions. You and JetLimo agree to submit to the personal and exclusive jurisdiction of the courts located within Ventura County, California.

Waiver. The failure of JetLimo to exercise or enforce any right or provision of this TOU Agreement or breach of this TOU Agreement by you shall not constitute a waiver of such right or provision.

Severability. If any provision of this TOU Agreement is unenforceable, such provision will be changed and interpreted to accomplish the objections of such provision to the greatest extent possible under applicable law and the remaining provisions of this TOU Agreement will continue in full force and effect.

Statute of Limitations. You agree that regardless of any statute or law to the contrary, any claim or cause of action arising out of or related to use of the Services or the TOU Agreement must be filed within one (1) year after such claim or cause of action arose or be forever barred.

Section Titles. The section titles in the TOU Agreement are for convenience only and have no legal or contractual effect.
